

GENERAL INFORMATION

The results stated in the test report are based on laboratory tests carried out exclusively on unused gloves.

A transfer of the results to gloves according to Care treatment requires the performance of appropriate tests. The glove offers protection against piercing with pointed objects as defined in DIN EN 388:2016, but there is no protection against pointed objects such as hypodermic needles. The glove provides some protection in case of accidental contact with chemicals, but it is not a protective glove against chemicals and micro-organisms in the sense of EN ISO 374-1:2016+A1:2018.

CHECK
